# **Bills Seeing Action This Week**

As of Friday afternoon, February 11, some of the Growth Management bills we are following have died, and some are moving forward successfully. There may be changes over the weekend, such that by the time this newsletter arrives, the information is out of date, but much will be accurate. Bills not listed here are all still in Rules Committee, waiting to be pulled for a vote on the floor of the respective chamber.

#### Bills that have died in committee include:

- SB 5390, Increasing housing supply through the GMA and housing density tax incentives for local governments.
- SB 5670, Creating additional middle housing near transit and in areas traditionally dedicated to single-family detached housing

#### Bills that have moved ahead include:

### February 17 public hearings:

▲ SB 5042 Concerning the effective date of certain actions taken under the GMA (relates to vesting). This bill has passed the Senate and is scheduled for public hearing in the House Environment & Energy Committee on February 17 at 1:30 pm. Sign in PRO for this bill here.

▲ SB 5428 Increasing housing supply through the GMA. This bill has passed the Senate and is scheduled for public hearing in the House Environment & Energy Committee on February 17 at 1:30 pm. It has been renamed "Concerning the application of the state environmental policy act to temporary shelters and transitional encampments to provide clarity and predictability to jurisdictions about categorical exemptions for temporary shelters and transitional encampments". If passed, this bill would allow exemption from SEPA review requirements for siting a temporary shelter or transitional encampment if 13 conditions are met, until August 1, 2032. #### February 18 public hearing

▲ SB 5312 Facilitating transit-oriented development and increasing housing inventory. This bill has passed the Senate and is scheduled for public hearing in the House

Environment & Energy Committee on February 18 at 10:00 am. Sign in PRO for this bill here.

HB 1717, Concerning tribal participation in planning under the GMA, has passed the House of Representatives but has not been assigned a committee in the Senate.
