TIME ALLOWED TO "CURE" (CORRECT) REJECTED BALLOTS

You have dropped off your ballot in the mail or in a drop box. What next?

Trained election workers handle the ballots. Signatures on the envelope are matched to the one on file for the voter. If the signature is mismatched or missing, the voter is notified at the address and phone number on the registration record to provide a verifiable signature. The deadline to cure (correct) a ballot is November 29, the date of election certification.

Once signatures are matched, ballots are accepted, removed from the security sleeve and reviewed for possible scanning issues such as folds or tears. Ballots are scanned on equipment separate from any internet or network access, then securely stored.

Check at VoteWA, https://voter.votewa.gov/ WhereToVote.aspx, for the status of your ballot and your voting history, or to update your registration record.

ACTION WORKSHOP FOR LEGISLATIVE SESSION OFFERED

December 10, 2022, is the date for the virtual LWVWA Action Workshop focusing on the 2023 State Legislative Session. Panels and speakers will address what's expected with the League's key issues as well as how to work effectively with your state legislators.

CONTACT SENATORS TO SUPPORT ERA

The Equal Rights Amendment was first passed by Congress in 1972 but has thus far failed to become part of the Constitution. The last of 38 states, the required number for ratification, approved the amendment in 2020, long past the deadline first established as 1979 then extended to 1982. However, Congress can act now to remove the ratification timeline so the ERA can pass once and for all.

Both our National League and the LWVof Washington State posted the following plea to members with an easy form to add your voice:

This country has waited too long for the Equal Rights Amendment (ERA) to become a part of the Constitution. Over 100 years after (some) women gained the right to vote, women and nonbinary people are still not guaranteed equality under the law. The League has been committed to the ratification of the ERA since it was first passed by Congress in 1972 because we believe that inequality hurts everyone.

On March 17, the U.S. House of Representatives passed legislation to remove the ratification timeline attached to the ERA. Now, the fight for the ERA is in the Senate. S.J. Res 1 is the companion bill in the Senate that would remove the timeline. We need 60 votes to pass the resolution. Contact your senators and ask them to cosponsor this resolution and ensure that the ERA is a part of our Constitution.

Inequality weakens us as a nation. The ERA is for every American, regardless of gender identity or sex.

Call or write our Senators. Even if we believe they will already support this effort, a groundswell of messages will help them argue for the resolution. You can also send your message through LWVWA at https://www.lwv.org/take-action/support-ERA.

WASHINGTON COMPANIES CONTRIBUTE TO BOTH PARTIES

Fix Democracy First (FDF), https://www.fixdemocracyfirst.org/, is an advocacy organization focused on achieving fair elections and government policies that reflect the will of the people, not the power of money. As a coalition partner of the LWVWA, attention has been drawn to the FDF's analysis of corporate campaign contributions as reported in a *Spokesman Review* article.

This article identifies Amazon, Microsoft, T-Mobile and Boeing as having contributed a combined \$823,075 for the midterm elections, not including superPAC money that is harder to track. Both Republican and Democratic candidates as well as a number of PACS supporting local ballot propositions received money. Corporations, according to the article, prefer appearing nonpartisan to maintain good will and access with whomever gets elected. LEAGUES FILE SUPREME COURT BRIEF TO LIMIT STATE LEGISLATURE DISCRETION IN ELECTIONS

States and League chapters from all 50 states and the District of Columbia filed an amicus brief in the *Moore v. Harper* case before the Supreme Court. The case concerns the so-called "independent state legislature theory" (ISLT), which, if adopted, would have far-reaching implications for the future of American democracy.

A ruling adopting ISLT would give state legislatures nearly unrestricted authority to set the rules for federal elections, prioritizing the ambitions of politicians over the American voter. Furthermore, if the Supreme Court condones this theory, it will undermine the role of state courts to protect voters when politicians create unconstitutional barriers to voting, draw unlawful voting maps, and invalidate direct democracy efforts like ballot initiatives.

Virginia Kase Solomón, CEO of the League of Women Voters of the US explained, "Giving states unchecked power to set rules for federal elections is an assault on the American voter. Historically, state legislatures have enacted the most harmful and suppressive anti-voter laws, and pro-voter groups like the League have relied on the ability to fight them in state courts. The Independent State Legislature Theory is a dangerous, fringe ideology that leaves voters effectively defenseless from harmful election laws."

Lunell Haught, President of the LWV of Washington State added, "Washington voters saw how the redistricting process was manipulated after the last census to advantage incumbents. We do not need politicians to decide the outcome of elections at any stage of the process. The Independent State Legislature Theory would allow that to happen. The League of Women Voters of Washington works tirelessly to refine and develop systems that work for Washington voters; ISLT is not a system that we need."

OUR LWVYC BEGINNINGS

On March 14, 1950, a group of women met at the Y.W.C.A for an organizational meeting to form a Provisional League of Women Voters of Yakima. A constitution and by-laws committee was formed, and at a meeting in April the constitution was adopted.

LWV FOUNDED

The League was officially founded in Chicago on February 14, 1920, just six months before the 19th amendment was ratified and women won the vote. Formed by the suffragists of the National American Woman Suffrage Association, the League began as a "mighty political experiment" designed to help 20 million women carry out their new responsibilities as voters.
