

Weekly Legislative Update: Climate Crisis & Energy

The 2023 legislature continues to introduce bills, and over 60 so far propose a mitigation or adaptation to climate change. We cannot fully evaluate or track all the bills, so we will focus on those most related to <u>League positions</u>, positively or negatively. We may also suggest revisions (amendments) to bills that need revision to make a positive influence. The bills below are a few that have hearings this week. You can make your personal position known before committee hearings through the <u>committee sign</u> in process. Links in the descriptions below will take you directly to the sign-in page for the bill. Your name will appear in the legislative record.

Priority Bills Needing Action This Week

SB 5312 - Creates a residential property assessed clean energy and resiliency (R-PACER)

program. Allows loans for improvements to be repaid through a lien on the property assigned so the obligation to repay the debt would remain with the property. Improvements in this case would be limited to energy efficiency, water conservation, clean and renewable energy, and resiliency projects. (We already have such a program for commercial properties, <u>C-PACER</u>.) These PACER programs enable property owners to make substantial investments that will save money well into the future and tie the investments to the benefits even they sell the property.

HB1012 Creating an extreme weather response grant program. The legislature recognizes the increasing risks and threats to socially vulnerable people (including pets) from extreme weather events such as heat, cold, smoke, and flooding. This bill will provide funding for communities with a demonstrated lack of resources, to meet the costs of responding to community needs during such periods for cities, counties, towns, and tribes that have emergency management organizations.

<u>HB 1391</u> Increasing energy efficiency in buildings. Defines grants and processes for overburdened and low-income communities to retrofit residences and buildings with energy efficiency appliances, insulation, repairs, indoor air quality improvements, and health and safety improvements. Funding optimized from the Climate Commitment Act and Federal Inflation Reduction Act. This is a climate justice focus, and such policies can make a big difference in the lives of people who otherwise would lack the resources to make improvements.

HB 1480 Energy resilience, cyber security, and all-hazard emergency management. Directs the Department of Commerce to include all hazards, including human and natural, in contingency plans in the event of energy shortages or emergencies. Previous law was not explicit on the hazards and risks. Weather events over the past years have disrupted energy supply sources prominently in several states. Internet disruption has also caused major power outages in North America. Our state experienced intentional damage to substations causing power outages. As we electrify to cleanup or energy sources, we must ensure we anticipate the significant risks to reliability.
