## **Bills We Support**

#### **HB 1317** Concerning Grassroots Lobbying Disclosure

Improves transparency in grassroots lobbying disclosure. Requires registration within 24 hours of the initial presentation of a campaign which encourages the public to influence legislation. Requires sponsor identification on advertising and mass communication and clarifies disclosure requirements of funding sources.

(**House** State Gov't & Tribal Relations: public hearing 1/24, Exec session 1/31)

#### **HB 1426** Concerning campaign contributions by controlled entities

Requires contributions made by an individual and an entity that individual controls be aggregated and adds requirements for limited liability corporations to declare a business purpose other than making campaign contributions.

(House State Gov't & Tribal Relations: public hearing 1/27, Exec session 2/1)

#### **HB 1677** Concerning Campaign Finance Disclosure

Updates campaign reporting deadlines to ensure voters have access to campaign financing information when ballots arrive. Requires sponsors to identify political ads to vendors when order is placed. Authorizes the PDC to use the public disclosure transparency account for project-based expenditures to meet increasing demand for technology and reporting improvements.

#### **SB 5207** Concerning campaign contributions by controlled entities

Requires contributions made by an individual and an entity that individual controls be aggregated and adds requirements for limited liability corporations to declare a business purpose other than making campaign contributions.

(**Senate** State Gov't & Elections public hearing 1/24/23)

#### **SB 5284** Concerning Campaign Finance Disclosure

Updates campaign reporting deadlines to ensure voters have access to campaign financing information when ballots arrive. Requires sponsors to identify political ads to vendors when order is placed. Authorizes the PDC to use the public disclosure transparency account for project-based expenditures to meet increasing demand for technology and reporting improvements

(Senate State Gov't & Elections public hearing 1/24/23, Exec session 1/31/23)

### **Public Financing of Legislative District Campaigns (no bill numbers yet)**

Using the proven Seattle Democracy voucher program as a model:

- Expands small donor financing of elections by providing vouchers to give to candidate(s)
  of choice
- Offers an option for funding campaigns that does not rely on wealthy and influential donors
- Requires limits on election spending, demonstrated public support, and participation in public debates for those opting in
