### Bills Needing Action This Week

*Please read Bills We Support to see the latest status of other bills.*

Committees in both chambers have been holding public hearings on the bills from the opposite chamber that are still viable. The next cutoff date is Wed., March 29, when policy bills must be out of committee. The Budget is taking most of the Legislative energy, and at this point, there are no public hearings scheduled for bills we support. But soon we will be asking for emails to your Legislators urging passage of our priority bills. Bills in **RED** below are in the opposite chamber. These are the bills we are following now. Each bill's weekly progress is reflected in the green notes at the end of the bill description.

Detailed instructions are in this week's Legislative Newsletter. Remember, only authorized members can speak for the League; the Issue Chairs will do that, so please leave the "Organization" box blank. A more powerful influence is many voices speaking for themselves rather than many voices speaking for the League.

### Bills We Support

#### **ESHB 1048 Enhanced Washington Voting Rights Act**

This bill amends sections of the Washington Voting Rights Act to clarify what constitutes a violation of the act. It seeks to protect members of classes who do not have an equal opportunity to elect candidates of their choice through methods that have created vote dilution or polarized voting. *(3/4 passed House 57 - 38- 0 -3. SENATE, public hearing 3/14.) (Executive session scheduled, but no action was taken in the Senate Committee on State Government & Elections on 3/17.) (Executive session in the Senate Committee on State Government & Elections amendment limiting recovery to \$30K failed, due pass recommendation passed and moved to Transportation Committee. 3/24.)*

#### **HB 1241 Addressing Harassment**

This bill modifies crimes of harassment and cyber harassment to cover conduct that is lewd or threatens bodily injury, property damage, confinement, or other malicious threats. Increases penalty for harassment of an election official to a class C felony. Allows election officials who are

harassed to apply for the address confidentiality program. (3/8 **House:** passed 90-7-0-1. **Senate:** 3/10 first reading, referred to Law & Justice.)

**HB 1541 Establishing the Nothing About Us Without Us Act (Lived Experience)** provides the means for including underrepresented populations in policy making discussions where their lived experience can impact decisions made that would affect their group. A bill last year provided stipends enabling certain populations ability to participate; this bill gives them access. (**House:** passed, 3/7 83-12-0-3. **Senate:** in State Gov't & Elections: Public Hearing 3/21, Exec. Session 3/24 passed to Ways & Means)

**SSB 5082 Abolish Advisory Votes** Advisory votes are questions that appear on the ballot regarding state expenditures that have already been passed by the legislature. By having voters mark "repealed" or "maintained", the wording suggests that they are a binding referendum. However, the results have no impact, and therefore are inconsistent with League principles. Required to be first on the ballot, they confuse and discourage voters. In addition, they add significantly to the costs of elections. (**Senate:** 2/8 passed 30-18-0-1. **House:** 3/21 executive action taken: SGOV - Majority do pass, Minority do not pass. 3/23 referred to Rules 2 Review.)

### **SSB 5112 Secure Automatic Voter Registration.**

Using identifying documents as a prompt, Automatic Voter Registration registers voters and updates existing voter registrations at Dept. of Licensing. Transaction time is shorter, less costly, and registers more voters. Accurate and updated registration reduces undeliverable election mail, provisional ballots, and same-day registration. Confirmation of the registration is mailed to the voter by the appropriate election agency, and the recipient then has the option to decline the registration. This automatic registration process is used successfully in Alaska, Colorado, Oregon, Delaware, and Massachusetts, and is deemed safe, secure, and efficient from beginning to end. (**Senate:** 2/15 E2SSB passed Senate 38-10-0-1, **House:** State Gov't & Tribal Relations public hearing 3/10, Exec. session scheduled for 3/15) (Executive action taken in the House Committee on State Government & Tribal Relations, Majority; do pass with amendment(s), Minority; without recommendation, 3/15.) (Referred to Transportation, 3/17.) (Public hearing in the House Committee on Transportation on 3/23.)

**SSB 5208 Updating the online voter registration process** by allowing voter applicants to provide the last four digits of social security number for authentication. (**Senate:** 2/1 Passed 29-18-0. **HOUSE:** 2/3 SG&TR, Public hearing 3/10, Exec. session 3/21, referred to Appropriations)

## **Bills We Are Watching**

**SSB 5182** Concerning candidate filing deadlines and procedures

(**Senate:** passed 2/28: 48 0 0 1. In **House:** public hearing 3/14, Exec. session 3/21, 3/24 referred to Rules Review)

## Companion Bill Moving Forward

### [HB 1158/SB 5082](#) **Abolish Advisory Votes**

Advisory votes are questions that appear on the ballot regarding state tax revenue increases for expenditures that have already been passed by the legislature. By having voters mark "repealed" or "maintained", the wording suggests that they are a binding referendum. However, the results have no impact, and therefore are inconsistent with League principles. Required to be first on the ballot, they confuse and discourage voters. In addition, they add significantly to the costs of elections.

[SSHB 1229/ESSB 5112](#) **Secure Automatic Voter Registration** Using identifying documents as a prompt, Automatic Voter Registration registers voters and updates existing voter registrations at Dept. of Licensing. Transaction time is shorter, less costly, and registers more eligible voters. Accurate and updated registration reduces undeliverable election mail, provisional ballots, and same-day registration. Confirmation of the registration is mailed to the voter by the appropriate election agency, and the recipient then has the option to decline the registration. This automatic registration process is used successfully in Alaska, Colorado, Oregon, Delaware, and Massachusetts, and is deemed safe, secure, and efficient from beginning to end.

[HB 1443/SB 5208](#) **Updating the online voter registration process** by allowing voter applicants to provide the last four digits of social security number for authentication.

### [SSB 5047/HB 1048](#) **Enhanced Washington Voting Rights Act** (House bill still active)

This bill amends sections of the Washington Voting Rights Act to clarify what constitutes a violation of the act. It seeks to protect members of classes who do not have an equal opportunity to elect candidates of their choice through methods that have created vote dilution or polarized voting.

### [SB 5616/HB 1541](#) **Establishing the Nothing About Us Without Us Act (Lived Experience)**

provides for including underrepresented populations in policy making discussions where their lived experience can impact decisions made that would affect their group. A bill last year provided stipends enabling certain populations ability to participate; this bill gives them access.

## Bills With No More Action This Session

### [HB 1174](#) **Improving Access and Removing Barriers to Jail-Based Voting**

Provides access to registration and voting to those incarcerated in county jails while awaiting trial. *(House State Gov't & Tribal Relations: public hearing 1/13, Exec. Session 1/31, SHB passed w/ do pass recommendation, 2/2 referred to Appropriations)*

[HB 1475](#) Increasing access to elections by allowing ballot submission via online portal for certain populations. *(HOUSE SG & TR public hearing 1/25)*

**[HB 1567](#) Commissioning a study on Conservation District election costs** This bill is in response to concerns expressed last session from conservation districts about the cost burden of moving their elections to the general ballot. The League published the results of our study on their election methods and procedures in May 2011 in this [report](#). Our position is these elections should be held in regularly scheduled elections to increase public engagement and voter participation. *(House SG & TR public hearing 2/7, scheduled for exec session 2/10 passed out of committee w/ do pass recommendation, 2/14 ref. to Rules 2nd Review.)*

**[HB 1592](#) Ranked Choice Voting for Presidential Primaries.**

This bill would eliminate “wasted” primary votes and produce choices with broad voter support for delegates representing their party’s candidates at their National Convention, where presidential candidates are selected. If one or two candidates are running, the current election method is used (Republican side of the ballot in 2020). If there are more than two candidates, Ranked Choice Voting is used to rank up to five candidates. (Democrat primary ballot in 2020). Post-election, counties send certified election data to the SoS for tabulation and publishing of the statewide election results. SoS office is also charged with developing public educational materials for the public and training for county auditors. *(House: 1/25 in State Gov’t & Tribal Relations)*

**[SB 5153](#)** Concerning information of underage applicants for drivers license/registration to vote. *(Senate State Gov’t & Elections public hearing 1/17, Exec. Session 1/20, passed out of committee, 1/23 to Rules for 2nd reading.)*

**[SB 5209](#)** Universal Civic Voting *(Senate State Gov’t & Elections public hearing 1/31, Exec. Session 2/7, 2/8 to Rules Committee)*
