Two important cutoff dates have now passed. Policy bills had to be out of the house of origin by Feb. 17, and some bills with fiscal implications passed out by Feb. 24. Bills with larger fiscal implications have until March 8 to leave the house of origin. Public hearings in the opposite house begin again this week.

SB 5284 Concerning Campaign Finance Disclosure

Updates campaign reporting deadlines to ensure voters have access to campaign financing information when ballots arrive. Requires sponsors to identify political ads to vendors when order is placed. Amendment replaces prohibition on contributions from or expenditures by foreign nationals with prohibition on contributions for or expenditures by foreign-influenced corporations.

HB 1317 Concerning Grassroots Lobbying Disclosure

Improves transparency in grassroots lobbying disclosure. Requires registration within 24 hours of the initial presentation of a campaign which encourages the public to influence

legislation. Requires sponsor identification on advertising and mass communication and clarifies disclosure requirements of funding sources.

Talking points:

This bill is an important upgrade to the existing law that is the result of years of stakeholder work and offers important clarification for campaigns and better disclosure for the public. Please ask your colleagues to move out of Rules to the Floor for a vote this week!

Bills We Support

SB 5207 Concerning campaign contributions by controlled entities

Requires contributions made by an individual and an entity that individual controls be aggregated and adds requirements for limited liability corporations to declare a business purpose other than making campaign contributions.

(**Senate** passed; yeas, 35; nays, 13; absent, 0; excused, 1, referred to House State Government & Tribal Relations 2/17)

SB 5284 Concerning Campaign Finance Disclosure

Updates campaign reporting deadlines to ensure voters have access to campaign financing information when ballots arrive. Requires sponsors to identify political ads to vendors when order is placed. The Senate policy committee removed two sections: Improving transparency in grassroots lobbying disclosure and authorizing the PDC to use the public disclosure transparency account for project-based expenditures to meet increasing demand for technology and reporting improvements. We will testify in support of adding this provision back to ensure sufficient funding for the successful and timely completion of these projects. The committee also adopted an amendment to replace prohibition on contributions from or expenditures by foreign nationals with prohibition on contributions for or expenditures by foreign-influenced corporations. This also removes the requirement for campaigns to collect certifications and replaces that with a statement from the corporation filed with the PDC. (Senate passed; yeas, 29; nays, 19; absent, 0; excused, 1, public hearing House State Government & Tribal Relations 3/10)

Bills We Are Watching

HB 1330 Adjusting the threshold for candidate contribution certifications related to foreign nationals

(**House** State Gov't & Tribal Relations: public hearing 1/24, Exec 1/31, Passed House 2/27 95-0-3, referred to Senate State Government 3/1) see also 5284 amending this section.

<u>SB 5152</u> Defining synthetic media and providing relief for candidates and campaigns (*Senate* passed; yeas, 35; nays, 13; absent, 0; excused, 1, public hearing House State Government & Tribal Relations 3/10)

Bills With No More Action This Session:

We were disappointed this bill was not scheduled for a hearing and are working with the <u>People Powered Elections</u> coalition to request a work session this year. We look forward to this priority bill progressing in 2024.

HB 1755 Establishing the democracy voucher program for contributions to state legislative candidates. This will create a public financing system for legislative elections using a statewide Democracy Voucher Program, similar to the Seattle Democracy Voucher Program. It will provide four \$25 vouchers to constituents in each LD to give to participating candidates of their choice. This will strengthen the voice of everyday people in state government by promoting broad, diverse, fair, and undistorted citizen influence and participation in electoral politics. Requires limits on election spending, demonstrated public support, and participation in public debates for those opting in to run for office using Democracy Vouchers.

HB 1426 Concerning campaign contributions by controlled entities

Requires contributions made by an individual and an entity that individual controls be aggregated and adds requirements for limited liability corporations to declare a business purpose other than making campaign contributions.

(**House** State Gov't & Tribal Relations: public hearing 1/27, Exec 2/1, referred to Rules - see companion bill 5207)

HB 1677 Concerning Campaign Finance Disclosure

Updates campaign reporting deadlines to ensure voters have access to campaign financing information when ballots arrive. Requires sponsors to identify political ads to vendors when order is placed. Authorizes the PDC to use the public disclosure transparency account for project-based expenditures to meet increasing demand for technology and reporting improvements. (House State Gov't & Tribal Relations: public hearing 2/8, referred to appropriations 2/17, no action taken before fiscal cut off - see SB 5284)
