## **Meet the Observer Corps! Protecting Your Right to Know**

The right to know what our government is doing is integral to our democracy. Join us for light refreshments, a chance to socialize with other members, and hear from the team of League members who cover our governmental meetings. Integral to the health of our democracy is protecting our right to know. Decisions that determine how our schools are run, at what level community safety programs will be funded, and how land in our towns will be used to impact our lives, are vital to our well-being. These kinds of decisions need to be made with public input and oversight. One

important way to ensure that is to observe government meetings. The League has been a champion of government transparency since our founding in 1920. It is one of our core principles and a vital part of our mission. Our efforts in this area reinforce our reputation of fairness, nonpartisanship, and trust. League members attend governmental meetings to learn what their government is doing and to monitor whether those meetings are conducted in an open and transparent way. Experience has shown the importance of the League being present to watch—and to take action when necessary.



“An observer is an individual who attends a governmental meeting, (city councils, school boards, hospital commission, etc.) notes what happens at the meeting, and reports back to the League and the community. By attending public meetings of local governmental bodies/agencies, observers learn more about what their government is doing. They learn about the issues facing their community and are empowered to take action if warranted. They also learn how issues are being addressed. Observers keep elected and appointed officials on notice; they let them

know that someone is watching what decisions are being made and how they are being made. They are neutral observers and do not participate in the meeting. Observers take notes and submit a brief report summarizing key issues discussed at the meeting.

## LWVSJ Happenings

### Recap of the March Membership Meeting

Our March meeting was both interesting and enlightening. Kyle Dodd, Environmental Health Manager for the county and Ethan Schmidt addressed the availability of water in the county and some of the challenges that have a direct impact on both availability and water quality. Climate change and salt-water intrusion are just two of the hurdles that need to be overcome. Water availability is the amount of water available for human purposes without harming the ecosystem. The county has been designated a critical aquifer recharge area because its aquifers are highly susceptible to contamination, particularly from seawater intrusion. Accurately measuring the amount of groundwater reserves in the islands generates controversy since most of the 5,400 wells in the county are private exempt wells that do not require meters. While much of the county population is served by private wells, surface water reservoirs and lakes supply drinking water to Friday Harbor and Eastsound. Since precipitation is the only source of recharge for surface and groundwater supplies, understanding the rate of recharge and withdrawal becomes critical in future growth. The meeting was followed by a question and answer period.

Additionally, a few weeks ago, the US Senate reintroduced the *John R. Lewis Voting Rights Advancement Act (JLVRAA)*, which would restore provisions stripped from the *Voting Rights Act of 1965* and prevent voter discrimination. Our mission is to empower voters and defend democracy, **but we cannot do it alone: we need Congress to support the passage of the JLVRAA**. We recently created a template for your local and state League to use to

## Last Month in the State Legislature

### The 2024 Legislature Ended *Sine Die*, March 7

The final day of the 2024 legislative session was Thursday, March 7. After 60 days in session, *sine die* was called. *Sine die* is a Latin term that references the closing of a session “without day” set for reconvening. This concluded the legislative biennium, as well as the 2024 session. The new biennium begins January 13, 2025, after the 2024 elections.

There were many successes and some disappointments during the biennium, and particularly this year, after which three-fourths of the legislators face reelection. A number of those have decided to retire from the legislature, but most will try to retain their seats. That means that many controversial bills did not get considered or did not pass.

The three supplemental budgets—operating, capital and transportation—were passed in the final days of the session.

Legislators chose to adopt three of the six Initiatives that were signed by the statutorily required number of voters and submitted before the session began. Those included:

- I-2081—Parental Rights;
- I-2111—Prohibiting Income Tax; and
- I-2113—Vehicle Pursuits.

The other three initiatives will go to the November ballot for a vote of the people:

- I-2109—Repeal the Capital Gains Tax;
- I-2124—Long-Term Care; and
- I-2117—Repeal the Climate Commitment Act.
