voters or vvasnington submitted a petition with more than 200 signatures to the governor s office urging him to sign the bill; the opposition sent more than 9,000 messages.


The bill was requested by Chris Reykdal, Office of Superintendent of Public Instruction, and cosponsored by Senator Claire Wilson. Representative Monica Jurado Stonier was the prime sponsor of the companion House bill, HB 1407.

A variety of backers included the Washington State Coalition Against Domestic Violence, Washington Education Association, Planned Parenthood of the Great Northwest and the Hawaiian Islands, Washington State Department of Health, YMCA, Governor's Interagency Council on Health Disparities, statewide Parent Teacher Association, along with students from various grade levels and colleges.

The opposition to this bill has already started a campaign to gather signatures to place Referendum 90, which would repeal SB 5395, on the 2020 fall ballot.

## **Elections in the Time of Coronavirus**



As the nation copes with the coronavirus outbreak, we're seeing calls for more flexibility in voting. It's critical to safeguard our election process to ensure that the upcoming elections are secure and that all voters have access to cast their ballots. While Washington State is a leader in mail-in voting, it's time to advocate for this at the national level.

Last week, Congress passed the Coronavirus Aid, Relief, and Economic Security Act (CARES Act) and while we're pleased Congress came together to provide desperately needed relief, the bill fell short of the \$2 billion in election funding needed to safeguard the right to vote in the upcoming November election. The League of Women Voters has called on Congress to prioritize elections in the next round of stimulus.

Additionally, Senators Amy Klobuchar and Ron Wyden have introduced the <u>Natural Disaster</u> and <u>Emergency Ballot Act</u> (co-sponsored by both Washington State senators) to expand voting by mail to all states and offer contingency plans that would allow Americans to vote in the event of an emergency.

## **Census: Be Counted**


In these times of uncertainty, standing together is critical, even if it's at a distance. Completing the census (and helping in getting out the count) are two actions we can take to support our communities and participate fully in our democracy during the coronavirus crisis. More than \$800 billion of federal funding for states and localities is also allocated according to official census counts. This determines the number of seats in Congress for each state and affects decisions and funds for schools, hospitals, roads, infrastructure, and other areas of daily life.

# Want to Learn More About Ranked-Choice Voting?

As a result of its election methods study, the League of Women Voters of Washington "supports the concept of a majority vote requirement for winners of single offices such as mayor or governor, as long as it is achieved using a voting method such as the instant runoff vote, rather than a second, separate runoff election." The <a href="2020 Issue Paper on Elections">2020 Issue Paper on Elections</a> provides more information about the League's stance.



Ranked-choice voting (RCV), sometimes referred to as "instant runoff voting," is an electoral system that allows voters to rank multiple candidates in order of preference on their ballots. If a candidate wins a majority of first-preference votes, then that candidate is declared the winner. If not, the candidate with the fewest first-preference votes is eliminated. A new tally is then conducted to determine whether any candidate has won a majority of the adjusted votes. The process is repeated until one

candidate wins an absolute majority. You can read more in the League's <u>studies and</u> <u>reports</u> on its website.

The LWVWA supported RCV in the 2019-2020 legislature with <u>HB 1722</u> and <u>SB 5708</u>. These companion bills would allow local jurisdictions to circumvent the top two primary system and implement RCV for the general elections. The LWVWA has supported these bills since introduction and anticipates supporting the bills that will be introduced in the 2021 session.

## Washington State Nonprofit Conference Goes Virtual



In light of the coronavirus, and out of concern for the well-being of the community, Washington State Nonprofits has decided to change how it implements its <u>2020 Washington State Nonprofit Conference</u>, *The Power of Participation*. It will no longer be held in-person at the Meydenbauer Center in Bellevue on May 19 and 20.

Instead, the conference will be held on the same dates as follows:

- Many of the workshops and some other aspects of the conference will be virtual, along with some new features, on the same conference days, so save those dates!
- Conference workshops will be listed on the Washington State Nonprofits website, with many of the current sessions included but offered in new, creative, and interactive ways. The conference agenda is under development and the offerings be posted by April 10 and completed by April 15.
- All three of the daylong Deep Dive sessions will be in webinar format. Each session will
  consist of a series of three webinars, spaced out over two to three weeks. This will
  include the same great content and presenters as originally scheduled. Planned dates
  are targeted for June and July 2020. Exact dates and times are to come.

Overall the conference will have the same price structure, and there will still be opportunities for connecting, sharing, and finding answers to your most pressing questions. You can still use the <u>registration link</u> to register for the conference. Members of the League of Women Voters of Washington are eligible for the member rate (the discount code for local Leagues is on the <u>member section</u> of the LWVWA website). Early-bird discount member fee of \$192 goes through May 4. After that, the member price is \$228.
